The Department Boys State Committee, The Board of Directors, and the Administrative Staff remind you of the **extreme importance of conducting interviews of all prospective candidates** before recommending they be accepted to American Legion Boys State. **All candidates MUST be approved by an official at the local American Legion post.**

Those young men chosen **MUST** be able to arrive between the hours of **12 noon and 3:00 p.m.** Sunday, June 19, for registration and **MUST** be able to stay the entire week.

Please note that the only person who can authorize late arrivals or early departures from the program is the Director of American Legion Boys State. No one else may do so. The Director will only authorize late arrivals or early departures due to emergency situations.
